



## I. PURPOSE

PT Merdeka Copper Gold Tbk (hereinafter referred to as "MCG") recognizes that effective energy management is a critical component of metal and mineral mining operations. We are committed to:


1. Complying with laws, regulations, and requirements related to energy efficiency, energy utilization, and energy consumption.
2. Developing and establishing energy efficiency objectives, targets, and programs continuously that align with MCG's Climate Change Policy.
3. Continuously improving energy performance and energy management.
4. Ensuring the availability of energy information, including energy consumption, and the assignment of human resources with competencies in line with the requirements to achieve energy conservation goals and targets, including conducting regular energy audits.
5. Encouraging the procurement of goods and services that improve the MCG's energy efficiency performance.
6. Promoting design activities that consider the principles of energy efficiency.
7. Conducting life cycle assessments to identify energy efficiency opportunities and enhance energy performance.
8. Communicating the MCG's Energy Policy through various internal and external communication channels to encourage the participation of employees, suppliers, and contractors in the implementation of the MCG's Energy Policy.

## IV. GOVERNANCE

The MCG Sustainability Committee is responsible for providing strategic direction and oversight of the implementation of the MCG Energy Policy. This includes monitoring overall performance and progress, ensuring alignment with corporate sustainability objectives, and reporting periodically to the Board of Directors.

To support the implementation of the policy, the Sustainability Committee establishes an Energy and Climate Working Group, led by the ESG and Climate Change Manager, with members consisting of site energy managers and MCG's Environmental Manager.

The Energy and Climate Working Group facilitates policy implementation across all sites by promoting collaboration, disseminating best practices, supporting capacity building, and consolidating progress updates. The Working Group reports the progress of the Energy Policy implementation periodically to the Sustainability Committee.
